The Shurmer Place expansion is scheduled for completion by August 2014. Residents will have access to many amenities and state-of-the-art features providing for a comfortable, homey environment and life style. Independent and assisted living options will be available.

First floor amenities will include a full service kitchen in the main dining room. The library will have a computer station. All apartments will be wired for wifi. Outdoor areas include an upper patio that will connect to the main dining room and a walk way to the gazebo. The lower level patio will have a wrap around patio with a fountain, and a memorial brick garden.
